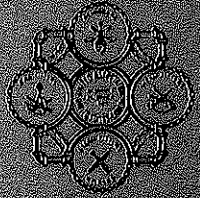

I do not often get into political rants in my letters but I feel that with the provincial election coming this fall we must keep you all informed when we know that our livelihood is at stake. Tim Hudak and the Conservatives are not friends of Labour. Tim Hudak has told the Ontario Pipe Trades directly that if he is elected he will do away with C of Q inspections on jobsites. He said he will "scrap" the Ontario Human Rights Tribunal, calling it a "kangaroo court" and a waste of taxpayer's money. He wishes to make it harder to receive worker's compensation payments and he wants to take away our organizing rights as Unions. If the Conservatives are elected they will make it easier for non-union and CLAC to invade our area and steal our work. 
We have been asked by some of our Contractors to provide Safety Training Documentation so they can forward it to their Clients as required. I know that all of the members carry the Documentation with them on the job in case they are required to show proof of Training. But, we would like to get copies of all Documentation for our members for our files in case we need to forward something to a Contractor. Please stop by the office and bring in copies of Safety Training, WHMIS, C of Q's etc., and we will make copies for our files. This will help us out in the future in order to fulfill this requirement from our Contractors. We will be updating these files over the next little while, so we may be contacting you for some information.

Over the summer we are looking at doing a 0-8 Ton Mobile Crane training course, and if we have the demand, we may do another one in the Fall, or more if required. The training is done through IHSA, and will be a 40 hour approved course with Certification. Space is limited to 8 per course, and we have a few spots filled already for a Tentative Start date of July 11<sup>th</sup>. Also we will be having Platform lift and Forklift training as required, please contact me if interested and I will schedule courses as needed.

We have been dispatching some members to The Lower Mattagami Dam Project North of Kapuskasing, and they require an OPG security clearance be done for access to the site. If you have not done it, please stop by and you can get the paperwork for the application. The clearance is good for 2 years, and will need a full application for renewal. So if you think you are required to renew, please check with us. We will also be checking over all documentation as previously mentioned, and may be asking that you renew the OPG clearance also.

At this time I would like to wish you all a safe and healthy summer, and hopefully the weather will cooperate and make the outdoors a little more enjoyable than it has been lately.
